

Dear Marine Professionals:

In keeping with the tradition of previous years, Sector Maryland-National Capital Region (NCR) will hold another "Round Up" starting February 28, 2023. Our goal is to perform as many inspections as possible in areas where high concentrations of certificated passenger vessels are located. With limited resources, we feel this is the best way to prepare for the upcoming fishing and tourist season, while minimizing the need to take vessels out of service during this busy period.

Primarily, "in water exams" (Inspections for Certification and Annual Inspections) will be conducted during the "Round Up" period. Nevertheless, dry-dock exams may be included within the scope of this activity. Please keep in mind that an inspection to renew a Certificate of Inspection (COI) must be completed on or before the certificate's expiration date; however, an annual exam may be conducted within three months before or after the COI anniversary date (date of expiration). The scheduled dates for the 2023 Round Up are below and may be subject to change based upon demand. If your vessel's location is not listed below, we will still be able to schedule your inspection during this Round Up window timeframe.
